1.	<p><b><u>Application form</u></b></p> <ul style="list-style-type: none"> <li>· Dully filled in all blanks in English or Spanish and signed <u>and dated by the applicant himself.</u></li> <li>· If the applicant is under the age of 18, <u>both parents</u> or legal guardian/s must present “Letter of consent” signed + original passports + photocopies + valid birth certificate of the minor translated into English or Spanish. Application form must be signed by both parents or legal guardian/s.</li> </ul>	
2.	<p><b><u>Original letter from local sponsor</u></b></p> <ul style="list-style-type: none"> <li>· Written in English <u>stating purpose of trip, qualification, salary and start date of employment in the UAE “Not older than one month”.</u> If sponsored by family member, Original NOC is required from his/her local sponsor is also mandatory stating qualification, salary and start date of employment.</li> <li>· If self-sponsor, copy of trade license officially translated into Spanish or English.</li> </ul>	
3.	<p><b><u>Passport</u></b></p> <ul style="list-style-type: none"> <li>· Passport with valid UAE residence visa with a minimum validity of 3 months from the date of expiry of requested visa.</li> <li>· Passport must have at least 2 empty pages</li> <li>· Passport validity of 3 months from the date of expiry of requested visa.</li> <li>· Passport not older than 10 years, signed by bearer. Undamaged pictures securely affixed with/to passport.</li> <li>· Previous passport, if applicable.</li> </ul>	
4.	<p><b><u>One recent biometric passport sized photographs</u></b></p> <ul style="list-style-type: none"> <li>· Pictures must comply with EU recommendations (Refer to website for specifications)</li> <li>· Should not be older than 6 months with white background.</li> </ul>	
5.	<p><b><u>Photocopies</u></b></p> <ul style="list-style-type: none"> <li>· Passport pages containing personal data and residency visa</li> <li>· Previous Schengen, US, UK, Canada, Japan visas.</li> </ul>	
6.	<p><b><u>Overseas medical insurance.</u></b></p> <ul style="list-style-type: none"> <li>· Valid for the duration of the requested visa and all Schengen countries. Must cover all risks expected during the time of stay in the Schengen area, including repatriation. Minimum coverage is 30,000€ + repatriation. (Medical insurances connected to credit cards are not accepted)</li> <li>· Conditions must be stated either on insurance document or on separate confirmation letter “Insurance Policy / Table of benefits”</li> </ul>	
7.	<p><b><u>Proof of relationship with EU citizen</u></b></p> <ul style="list-style-type: none"> <li>· If the citizen is from Spain. the applicant can provide any of the following documents <ul style="list-style-type: none"> <li>a) Copy of the <i>Libro de Familia</i>, as long as it has been issued within the <b><i>last six months</i></b> (only in those cases where el <i>Libro de Familia</i> has been issued by the Embassy of Spain in Abu Dhabi the <i>Libro de Familia</i> will be accepted regardless of the date of issuance.</li> <li>b) Marriage certificate issued by the correspondent Spanish “Registro Civil” within the <b><i>last six months</i></b>.</li> </ul> </li> <li>· If the citizen is from any other EU country – Attested marriage certificate or similar issued within the last six months, registered in a EU country and officially translated into Spanish.</li> <li>· Proof that the applicant is either travelling along with the EU citizen or joining him/her in Spain (For example: plane ticket reservation)</li> <li>· Copy of either DNI/National ID or passport of EU citizen.</li> <li>· MINORS – in case of divorce/separation, official document stating custody.</li> </ul>	
8.	<p><b><u>Proof of financial dependence for children over 21 and ascendants</u></b></p> <ul style="list-style-type: none"> <li>· Sworn statement from EU citizen stating that applicants his/her dependent.</li> <li>· Document from applicant’s country of origin proving financial dependence.</li> </ul>	
9.	<p><b><u>Return ticket booking</u></b></p>	

previous appointment (WALK-IN); there is NO VISA CHARGE for this procedure. Visa is free of charge, although BLS will charge its usual administrative fee for collecting and processing your application. However, only VALID & RECENT documents issued by the authorities of a Member State certifying your relationship entitle you not to pay for your visa. Applicants can submit as category C - "Tourism" (revise checklist) if they do not meet these requirements.

**TERMS & CONDITIONS**

This information leaflet has been generated by the Embassy of Spain to the UAE and is valid for the visa application in the United Arab Emirates. It stipulates the legal requirements requested by this Embassy for this type of visa and is carried out in cooperation with BLS to facilitate your visa application. READ IT CAREFULLY AND OBSERVE THE REGULATIONS. Applicants are suggested to apply well in advance to the intended date of journey. **Visa process can take up to 3 weeks after your submission at BLS, if granted.** THE EMBASSY DOES NOT PROVIDE ANY INFORMATION ON THE STATUS OF A VISA PROCESSING (neither by phone nor by email).

INCOMPLETE APPLICATIONS: Only complete applications can be accepted; **non-submission of required documents may lead to refusal of visa.** Once the application is submitted, no changes in dates or conditions of travel will be admitted unless duly justified.

VISA FEES: Must be paid upon submission of the above. Your application, passport and visa fee will be forwarded to the Embassy of Spain within one working day after submission (if submitted on Thursday, the application will reach the Embassy on Sunday). The service fee remains with BLS. **The visa fee is non-refundable.**

PASSPORT WITHDRAWAL: Only passport withdrawal is available for pilots and cabin crews. No passports can be withdrawn directly from the Embassy.

According to Spanish regulations, the Consular Section of the Embassy of Spain in Abu Dhabi, through BLS Global:

- May request any other documents or a personal interview.
- Should resolve all applications within 3 months.
- May file the visa application if it has not been picked up by the applicant within one month of notification or grant.
