

## FAMILY REUNIFICATION VISA

The applicants **must submit their application forms for this visa in person**, within two months since the notice of the resolution issued by the correspondent office in Spain. They must submit the following documents:

1. **National visa application** duly completed and signed by the applicant.
2. **Two recent color passport size photographs** with white background.
3. **Original of the residence permit** issued by the correspondent of office in Spain (autorización de residencia por reagrupación familiar).
4. **Original and copy of a valid passport** or other travel document signed by the applicant if required. The passport must be valid at least for four months since the date of submission.
5. **A good conduct certificate or equivalent** (only for applicants over 18 years old) issued by the local police authorities of your country of origin or/and by the countries where you have been living for the last 5 years. This certificate has to be legalized by the Ministry of Foreign Affairs in UAE or in the country where it has been issued; in the last case, the document must be legalized by our Embassy in that country too. Kindly note that for those documents issued abroad, the Hague Apostille might be required.

6. **A medical certificate** stating explicitly that the applicant does not have any disease according to the International Health Regulations (IHR) 2005. This certificate has to be legalized by the Ministry of Foreign Affairs in UAE or in the country where it has been issued; in the last case, the document must be legalized by our Embassy in that country too.

7. **Original marriage certificate for spouse**. Validity of the certificate must be 6 months maximum from its issue date.

This certificate must be legalized by the Ministry of Foreign Affairs in UAE or in the country where it has been issued; in the last case, the document must be legalized by our Embassy in that country too. Kindly note that for those documents issued abroad, the Hague Apostille might be required.

**8. Original birth certificates** for children.

This certificate must be legalized by the Ministry of Foreign Affairs in UAE or in the country where it has been issued; in the last case, the document must be legalized by our Embassy in that country too. Kindly note that for those documents issued abroad, the Hague Apostille might be required.
