<u>VISA FEES</u>- must be paid upon submission of the above. Your application, passport and visa fee will be forwarded to the Embassy of Spain within one working day after submission (if submitted on Thursday, the application will reach the Embassy on Sunday). The service fee remains with BLS. **The visafee is non-refundable.**

<u>PASSPORT WITHDRAWAL</u>- Only passport withdrawal is available for pilots and cabin crews. <u>No passports can be withdrawn directly from the Embassy.</u>
